Business:

- Welcome and Introduction of GFHA Board of Directors
 - o President, Gina Valentino, began by welcoming those in attendance, introducing pastpresident Katie Allison, introducing the current GFHA Board Members, and thanking the Brooksider for their hosting GFHA again this year.
- GFNCID Update
 - o Gina reported the GFNCID is approved and GFNCID assessments were collected via Jackson County. A letter to residents will be sent indicating no separate Dues billing is necessary because the dues are part of the GFNCID assessment collection.
- Elections
