Old Business

- Meeting Minutes
 - o November 17, 2009 Board Meeting Minutes
 - The board voted unanimously to approve the minutes as amended.
- 2009 Lighting Contest

 - Certificates were delivered to each of the winners. Barbara Martin suggested that the homes association purchase signs for each of the categories that can be placed in each winner's yard.
- Snow Removal
 - O The board had a lengthy discussion of snow removal as a result of the snow accumulation in Kansas City so far this winter. Joe Groebl mentioned that going forward the board may need to increase the amount budgeted for snow removal to \$8,000-\$9,000 per year. Joe also stated that it can be difficult to decide whether snow removal or plowing will be needed (often the choice to plow or put down salt must be made before a storm begins), and that the board should always put down salt if the City of Kansas City is doing so. This would take the burden of guesswork off of the board member assigned to snow removal.
 - O The board also discussed putting an article on snow removal in the upcoming newsletter. Issues that should be included are (1) homeowners should park their cars in their driveways if they know that it is going to snow so that the plows can plow the streets and (2) homeowners should strive to shovel their sidewalks.
- Financial Update

- o Philip Bouillette provided a brief summary of the financial condition of the homes association. The association had approximately \$17,000 of cash on hand for the end of 2009.
- The annual dues statement will be mailed in January. Gina Valentino will prepare a letter to be included with the invoices. Board members will review the letter prior to mailing.

 - o The board discussed initiatives for 2010. The biggest priority for 2010 will involve communication between the association and the residents. The board would like to update all contact information, provide for the receipt of each newsletter electronically, and to create the website.
 - o Another priority is the beautification of the entrance to Greenway Fields at the intersection of Greenway Terrace and Wornall Road.
 - The board also discussed obtaining estimates for leaf removal for fall 2010. There are companies that can remove leaves from the sides of the street if the residents will rake their leaves out of the yards to the edge of the street.
