Old Business

- Meeting Minutes

 - The board voted unanimously to approve the minutes as amended.
- Traffic Circle at Greenway Terrace/Pennsylvania
 - The driver who damaged the circle has paid for the cost of repairs, so this item is resolved.
- Park/Island Maintenance
 - o Terry Wolf, our landscaping liaison, has been dissatisfied with the service we are getting from our current landscaping contractor and has met with several other contractors to discuss their fees and what ideas they have for our neighborhood. He recommends that we terminate our contract with our current landscaper as soon as possible, so we can give them thirty days' notice and in turn have a new contractor start on October 1. It's important to have this happen so they will have a chance to implement some changes this fall before the weather gets too cold. He would like to have two budgets for landscaping: one for upgrades, and one for maintenance. Terry further stated that he's emphasized that our common areas need heat- and drought-tolerant plants. The Board voted to terminate the current contractor and agreed to move the September meeting up a week to make a decision by the end of the month.

 - Christian Schulz brought a draft layout of the issue for review; a few changes were made, and it was okayed for distribution.

- Certificate of Deposit for GFHA
