- Landscaping Contractor Update
  - Terry Wolf was absent, but workers from Lightning have been seen working on the common areas around the neighborhood.
- Neighborhood Garage Sale Sept. 30-Oct. 1
  - The sale seemed to go well, helped by beautiful fall weather. Three of the eight signs set out were stolen and will need to be replaced before the next garage sale is held, which may be in the spring. We'll coordinate with Armour Fields and/or Armour Hills when we schedule the next sale.
- Neighborhood Leaf Removal
  - o The e-mail response to our request for feedback on this issue was overwhelmingly positive; of all the e-mails received, only two were against GFHA providing this service. Gina was able to get a quote from Benjamin Lawn & Landscaping; they were willing to do the job for \$19/house (approx. \$7,000). As this amount was quite a bit higher than the amount that Joe Groebl was given a year or two ago, it will not be financially feasible to provide this service this year. Because of the timeline of how our budget is approved, the earliest that the neighborhood could provide this service would be 2013. We will discuss this issue at the next annual meeting.
- Nourished by Neighbors
  - The October 22 dinner was a success: there were two homes and eleven participants. The next dinner may be scheduled for February.

### **New Business**

  - David Bland & Marianne Roos will host the party. It will be from 5:00-7:00 p.m. on Sunday, Dec. 4 at 634 W. Meyer Blvd. Clem will look into serving dishes and glassware.
- Redistricting

Gina has some concerns about this; and she's planning on meeting with Jan Marcason to discuss this.
