Old Business

- Meeting Minutes
 - o November 29, 2011 Board Meeting Minutes
 - The board voted unanimously to approve the minutes as amended.
- Annual Holiday
 - o The party this year was a success: there were more attendees this year, and the food was excellent. Tasks to remember for next year: cover the countertops with towels in case of spills; bring tablecloths; don't bring as many meatballs!
- Neighborhood Leaf Removal
 - The 6400 block of Washington elected to do a block-wide leaf pick-up of the variety considered neighborhood-wide by the Board. Gina Valentino reported that although there was not 100% participation, it went very smoothly. The cost was ~ \$20/household.
- Water Main Break
 - The persistent break that has been plaguing 63rd St. between Wornall and Pennsylvania, as well as the entrance to Greenway Terrace, has finally been fixed. Neighbors called 311 for weeks to report the problem.
- Final Budget Report
 - o GFHA finished 2011 with a cash balance because there was no snow removal required in 2011.
 - The funding for the CID is beginning to show up for 2012.
 - There has been a slight kink in the process: the County under-assessed each household in Greenway Fields by \$.50.
 - Philip has prepared the 2013 budget, which must be presented to the City for approval by Jan. 30, 2012. He increased the snowplowing allotment to allow for more flexibility. This budget calls for an assessment of \$128.00/household for 2013.
 - o The City will respond to the submitted budget within 40 days.

Gina knows a concrete contractor and she will contact him to take a look.

 - Terry Wolf is concerned about the recent crime statistics, which the KCPD released. He's wondering what we can do to make it stop. He is willing to step up and attend police Roll Call events and serve on any sort of task force that may come together.
