 - Our primary ongoing issue with landscaping is the lack of water availability at Strawn Park and Monkey Island; without it, we have to pay Lightning to transport water from Shawnee, which is expensive. Terry has looked into various ways of getting water to the parks, but it is expensive and cumbersome, as the water main that needs to be accessed runs right under 63rd St. Clem Helmstetter is writing a letter to PIAC and has spoken with someone in Councilman John Sharp's office about this issue. It may not make sense to do any new plantings until the water situation is resolved.
 - o Terry will check into having someone evaluate the stability of the benches in Strawn Park.
 - He will also walk Lightning by the columns on Meyer and find out if they would need to add to their quote to maintain the landscaping around them.
- CD Extension
 - o The board voted to extend the \$10,000 Certificate of Deposit held by the GFHA.
- Newsletter
 - The February edition of the newsletter is ready to go out, pending one photograph from an advertiser.

New Business

 - The Feb. 4 meeting at the Brooksider was a success. There were about 65 adult attendees. Gina suggested that next year food not be served up on the stage, as that was a little awkward. The Brooksider has been paid.
