b. Finance update:

- i. Treasure update GFHA / GFNCID. Snow costs are adding up this year close to \$5K to date.
- ii. GFNCID Jackson County tax bills are out to residents for payment. Clem plans to bill Jackson County for all paralegal time spend on working this issue with the county administrator. This is the first time in 10 years that GFCID has been omitted from county tax bills.

Because of Jackson County not including the GFCID on county tax records, we are currently \$46,000 short of where we should be with dues collection.

Salt/plow is approx. \$1,500 per event, GFHA Board already spent \$5,000 this winter and has increased budget for this winter to \$7,000.
