- 1. Call to order Quorum present.

# a. Finance update:

- i. Treasure update GFHA -
  - 1. Wornall Baptist \$129 paid. \$18.50 x 2 HAKC fees only expenses. Account Balance remains high due to lack of activity over the summer.

## ii. GFNCID-

- a few owner's property tax payments trickling in from quarterly payers. CID Paid 2 months fees plus a few other monthly filing expenses. Soil services bill \$2,400 for maintenance & \$2,000 for dogwood replacements. \$1,440 and \$1,120 in June and July for security fees, in line with normal fees for this service. Trash fees have ceased, and trash has not increased in park since removal of the receptacles.
- iii. 2020 Assessment submitted to Jackson Co.
  - 1. after audit by HAKC, 5 homeowners have not paid assessment, which will be collected when home sells. Jackson County has sent notices. No changes on upcoming Dec tax bill.
- iv. MO Audit / Ethics and City Clerk annual report completed.
- v. Pending tax return filing as 501c3 due by Oct.
  - 1. taxes will be done and filed from previous year soon. Even NFP's have to file.

#### b. Events:

i. Picnic and Holiday Party. Board agrees to cancel all events for 2020. Hope to make it up ASAP.

#### c. Newsletter

- i. Loss of layout artist, thoughts on digital newsletter.
  - 1. Board agrees to go to completely digital format in an effort to be more environmentally friendly.
  - 2. Will work through block captains to insure we have accurate member emails.

## e. Security Updates - Joe.

- i. Any incidents in area recently?
  - 1. Six incidents in June, July and early August. Multiple car break ins in the neighborhood. Big problem throughout the city, expected to continue until school starts.
  - 2. Additional patrols will be on Greenway Fields Terr due to speeding on the narrow road.
  - 3. KCPD has lost apporx 100 hours this summer. Neighbors need to lock up their cars and belongings and be vigilant.
