Minutes of February 11: Approved as written.

Recent events/activities: Treasurer's report

John McMahon submitted the proposed budget for the new fiscal year. There was discussion about the budget and several clarifications were suggested. Included in the discussion:

There is adequate money in the budget to cover the cost of the annual brunch without charging residents. (The pancake breakfast will cost approximately \$3.50 per person.)

A donation will be made to the church for use of its facilities for the annual meeting since there is no charger of the space.

Adjustments will be made to the budget for capital improvements. This will come from the surplus.

Additional money will be added for postage to cover increase in the cost of postage.

It is not necessary to budget for the cost of the directory since it will not be reprinted until 2009.

The crime prevention item will be removed from the budget.

Social activities item will be clarified.

Wesley and Marsha will solicit for advertisement among local merchants and collect money for advertising in the newsletter as a means to bring in additional income for PH Homes Association.

John will update the proposed budget and have Mark Stiles post it on the website. Loring moved to appropriate budget with changes. The motion was seconded by Wesley Piercy. The Board voted unanimously to accept the budget for presentation to the members of the homes association on April 19.
