2015 budget to date was shared. Marianne reported the biggest issue we have are those who do not pay their homes association dues. Our dues range from \$14-28 which is significantly lower than other neighborhoods but does limit what we are able to do. Our fiscal year ends March 31st.

Questions from guests:

Committee Reports:

Overlay district:

Susan explained the overlay district and handed out a survey. There was a suggestion that we mail out the survey to all homeowners to gather opinions from a broader group and help build a consensus. Concern was expressed that the survey had not been approved by the Overlay Committee.

Question on what the boundaries are and how that was determined. Answer is that

because we have such a large association, the committee will determine which area to start with and which areas to add later. Members within the boundaries will vote and decide if they want the overlay.

The overlay district does not need the HOA blessing before presenting to the City Council, but it is recommended.

Question on why there isn't an architectural review board. Answer is currently there is no authority that they would have.

The Board will continue the overlay proposal review at the March board meeting and will determine next steps.
