Old Business:

Declaration of Restrictions – Susan Forrest will complete the necessary forms and present at the July meeting.

Leaf Removal – Jori Nelson reported on costs in nearby cities. The Board deemed the costs to be too expensive for PVHA to assume. At some future date, we may propose this idea to the City of Prairie Village Homes Association Committee.

Fountain relinquished to City – The City of Prairie Village has included repair of the fountain in its 2008 proposed budget and has earmarked \$30,000 for repairs.

New Business:

Bulk Mailing Permit – discussion tabled

Delinquencies – the Finance Committee recommended that Delinquent Accts, which needs to be analyzed in conjunction with Revenue and Accts Receivable be moved to the Finance Committee. Michelle Nash stated that the Finance Committee is in the process of identifying and prioritizing all financial issues (including delinquencies) and updating the Board at the next meeting.

Foreclosure – Per Susan Forrest, \$278.13 in delinquent dues is owed on a PV home that has gone into foreclosure.

990-EZ Tax Forms – HACCD has delivered the 2003, 2004, and 2005 forms to Susan Forrest. The 2006 Form 990-EZ is due to be filed in July, and we will expect to receive a copy of it shortly after the filing date.
