The Fall Festival is set for October 6th at Porter Park. We're looking for a popcorn supplier to replace the kettle corn guy who closed his business. Mely's in Corinth doesn't serve popcorn any more but can do hot fudge Sundays. The Board preferred a popcorn option over ice cream for the fall so Lissa will contact Velvet Crème and Topsys. Other additions to consider are helium balloons, consider cotton candy, or a popcorn machine.
