4. NEWSLETTER...Nancy Rusch

A newsletter will be going out shortly to announce the meeting. In addition we will

again publish a list of the properties (no names) that have liens for unpaid dues. A motion was made and seconded to offer amnesty on interest charges on all overdue dues if paid by December 31, 2010. The board approved this motion, and it will be included in the newsletter.

5. FINANCIALS...Larry Engel

We reviewed the monthly financial statement for September. Larry pointed out the new reserve for bad debt, which represents all dues more than one year past due. We will review with Clarence Foxworthy the possibility of further modifying this reserve after Dec. 31 to reflect additional unpaid dues from 2010. He is also considering a way to create a reserve for all unpaid dues which would be adjusted monthly. This would essentially achieve our goal of getting assessments on a cash basis.

6. CAPITAL IMPROVEMENTS...Phil Paschang

Work on the sidewalk project will likely start on Oct. 13. The board approved a payment of \$5000 to get the projected started. We felt comfortable doing this since the performance bond has been presented.

After we planted a bush to hide the solar panel from their view, the homeowner is now contented. We plan to plant one more bush to hide the panel from State Line.

7. NEW BUSINESS

Susan Richart reported that she has a Boy Scout who wants to clean up around the lake in the park. She will contact Peter Gross.

Richard Scarritt made a motion that the Verona Hills governing documents (Declaration of Restrictions, Homes Association Declaration, and Homes Association By-Laws) be added to our permanent records (HA-KC), added to our website, and furnished to all new board members. The motion was seconded and approved by the board.

Phil Paschang made a motion to establish liens on all properties that owe more than \$300 in past dues, subject to a review with HA-KC to see what we are charged for such actions. The motion was seconded and approved by the board. We later agreed to delay the action until after the interest amnesty period ends at the end of the year. In the meantime, Larry E. will check with HA-KC to see what we are charged to establish a lien.
