

Welcome to 2024!

January kicks off your homes association's fiscal year. Dues notices reflect an unfortunate reality

heading into 2024: Across-theboard price increases for goods, services and utilities you've no doubt witnessed firsthand.

For NWT, that means more funds for pool and irrigation services, mowing and tree trimming, to name a few. It means larger water and electric bills to maintain our entrances and pool. It means increased costs for pool supplies and treatments that keep algae from overtaking the pond.

It is within this wintry economic climate that your volunteer Board of Directors also takes on paying for maintenance deferred during several consecutive years when dues were steady but inflation persisted. We're also planning for some end-of-life-cycle projects, such as replacing the pool surface and one of the heaters.

The Board, tasked with maintaining NWT at the high standard to which we've all become accustomed, voted, in accordance with NWT

bylaws, to raise dues to \$660. Pay \$630 in full by Jan. 31 and save \$30. Or pay \$330 by Feb. 28 plus \$330 by April 30. **Late fees apply beginning May 1** — a change from previous years to streamline getting all members in good standing by pool season kick-off.

While association activity quiets in the winter, our big four committees — Grounds, Pond, Pool, and Social — are always planning. The phrase "many hands make light work" is never more evident than when our great events are taking place. A great place to build community is right here, so please consider it!

If you didn't volunteer last year, 2024 is a new opportunity for you. Volunteering is crucial to this neighborhood, providing all the amenities we've come to expect: the

pool, pond, trails, common areas, and social events throughout the year.

Volunteering helps keep our dues down as well. Two recent examples: I observed 114th Street neighbors Tony and Regina Wittman repairing the monuments at our entrances and refreshing them with a new coat of paint. Also, take note of the Ginkgo tree along Ridgeview Road at 117th Street. The tree and planting labor were donated by Millview Road neighbors Gary and Barb Lammers.

Had these jobs been hired out, it would have cost NWT many hundreds of dollars. Our well-kept monuments and exterior common areas are the first things drivers see when they enter or pass our neighborhood and think "this is where I would like to live." They offer a sense of pride when we head out into the world and return back home. They help keep our property values competitive.

We had a large turnout for our annual homeowner's meeting in November. Thanks to all in-person and by-proxy participants. Bylaws prohibit starting the meeting if there isn't a quorum representing at least 68 homes out of 459. Often Board members are scrambling, calling neighbors at the last minute to reach that quorum, but this year was pleasantly different, perhaps due to the referendum to curtail rental companies from buying properties in NWT.

Regardless, thanks on behalf of the Board for the great turnout.

Happy New Year, neighborinos — time to get going on those 2023 taxes! Unfortunately, your quarters spent on fish-feeding family fun down at the NWT


pondside deck aren't deductible.



It was a mostly quiet fall around your neighborhood water feature. For your information, the quarterper-handful fish feed machine was damaged beyond repair and the custom housing was scarred in a

break-in attempt by teens filming stunts on the dock on Nov. 29. A new machine will be installed in the spring using feed sales proceeds.

In early December, a skilled team of pond operators removed and cleaned the aerator motors for winter storage, treated the water, and installed the ice warning signs. As a reminder to the young, brave and foolish and the seasoned but fallible, it is never safe



to walk on the ice due to unknown ice thickness and pond depth. Please set a good example for young folks as you take the winter air at your pond.
