It's time again to begin looking at the next year. It has been another challenging year for the HOA as



we work to keep all our amenities in good repair and operational. We continue to experience rising costs and facilities that need to be

repaired. This has caused the Board to again raise the Association dues.

Dues will be \$700 per household for the 2026 budget year. We will most likely follow inflation in years to come with small dues increases year after year. There will be an early pay discount again next year. The dues payment timeline will be the same as last year with late fees assessed starting May 1, just like last year. This will also get everyone

ready for next year's pool season.

I wanted to highlight some projects we are funding this next year and list a few that we are not, that will need to be addressed in the future. We have budgeted money to replace the entrance monuments at 118th Street and the one at Northwood Drive. We are also budgeting for repainting the pool to help extend the life of the liner a little longer to set aside enough to have a full restoration done in the future.

Now for the projects that are looming in the future:

- The poolhouse needs a refresh with the floors refinished with epoxy coating.
- The design and size of our pool requires two heaters and one of needs to be replaced.

- (or may not) affect NWT, such as pool pump room requirements.
- The pool tower parking lot needs repair, repaving and restriping.
- Our 4½ miles of trails continue to deteriorate at a rate we can't keep up with the repairs.
- Our aging common-area irrigation system is in constant need of repair.

We continue to face many challenges with rising costs and expensive maintenance issues. The best way to be a part of the solution is to become involved in the different committees. For instance, Grounds manages half of our annual budget. Community help on small projects helps to keep dues in check.

select shingles that are listed in the deed restrictions.

• For fence projects there are some limits regarding where the fence can be placed in you yard. This information is in the deed restrictions.

Take your buckets and hand tools and stroll down the Millcreek trail to discover fun on the creek!


- Make pebble and weed soup.


member, on the Board of Directors and as the editor of the newsletter.
