Regarding a June Northwood Trails Facebook discussion about "receiving a letter from the HOA":

- Multiple board members walk the neighborhood regularly and observe things first-hand.
- Talking to a neighbor who's doing something that bothers you is always the first/best course of action.
- If a violation can't be resolved through conversation, a letter mailed from the board is the fairest way to notify a resident of their violation, i.e., to make sure that everyone gets treated with equal respect and fairness.
- Some, but not all, board members are on Facebook and read Northwood Trails group posts.
- If something needs to get done in a more effective process than a Facebook post, please engage in public discussion at a monthly board meeting. Meetings are on the second Tuesday of the month, 7 p.m. at the Olathe Community Center (until we return to Grace Church).

Examples of recent public comments include fences/ property lines and safety at our pool after dark.

Please remember that all board members are volunteers who are donating multiple hours of their time each month to serve all 450+ residents!

These are photos of a shed and long-term trailer, RV, and boat storage on Hunter Drive south of 119th Street. This is a non-HOA subdivision with newer \$300K houses. When our developer started Northwood Trails, he knew that "nice" subdivisions could look like this, and he wrote the seven pages of our Deed Restrictions to prevent that from happening. Anyone who buys a home here is made aware of HOA expectations at the time of purchase. The restrictions are available at eNeighbors.com > Documents > Architectural Guidelines.



#### **Pond Committee News**

It's been a quiet couple months around the neighborhood water feature ever since the air of excitement abated following the Fishing Derby.

Rain showers in early August gave way to mostly sunny days and high temperatures. The algae, green with envy over Pond Committee's seemingly successful efforts to subdue and smother the water weed, mounted a comeback and takeover attempt a few days later. Pond-area aqua-scientists deemed it the blue-green variant.

Over the next few weeks, the variant never truly threatened the popularity of the pond. Still, the Pond Committee elected to take action. Led by Pat Madden, committee chairman emeritus, the Treatments subcommittee boarded the neighborhood dinghy nearly a half-dozen times, dispersing the inputs meant to eradicate the Cyanophyta growth. Conservative doses were applied so as not to shock the fish population.

The aeration fountains' hours of operation were extended, but the scum persisted. The committee plans to tinker with input levels and will continue to fight the green fight.

In the meantime, your neighborhood common areas around the pond continue to offer relaxation, exercise, ambience and activity from the dock to the fairy trail.

Next up for the pond committee is the staining of the dock. The deck surface was replaced by your volunteer Pond Committee in 2018 at great savings to the Homeowners Association. The railings, entryway and pergola were built by a contractor in 2020. All that lumber has aged to a point ideal to protect the investment with a stain. The committee opted for clear stain that promises to bring out the natural color in the wood. We'll tackle that in September, so bear with us as the dock is closed for a few weeks.
