The contractor was basically complete with his part of the pond excavation, wall replacement and repairing the overflow pipe. However we do have a leak in the overflow pipe and the contractor has shared his plan to repair it in the coming weeks.

While the contractor focuses on the overflow pipe, we are moving forward with the next phase which is landscaping. We are in the process of getting bids for this work which will be started in the next month and completed in early spring. The third phase is also being worked and that is the replacement of the fountain wiring and then the installation of the fountains. The fourth phase will be the repair of the paths after all the construction traffic has ended. And then the final phase will be the restocking of the pond.
