GROUNDS COMMITTEE NEWS

It's been a busy Spring for grounds committee! Six trees were removed and surrounding thorns/twigs were raked up. Then 18 more trees were removed and thorn/twigs cleaned up all over again. Hopefully, all thorns

have been spotted (many were even stuck in the ground) and removed so everyone can now walk safely and play in the sand without worry about stepping or falling on them. No sooner did we get everything cleaned up when the pool water got forcefully drained over the volleyball court just prior to opening, so we cleaned up again. Storms came on the 16th and 17th of June and guess what? Clean up once again. The grounds committee is worn out!

On a positive note, six new trees were planted without a hitch on June 18th. Hoses are rolled up along the pool fence to be used for watering these trees this Summer and Fall by grounds committee members. Hopefully, grass can be planted in open areas this Fall as well.

Please help NWT by picking up bottles, beer cans and all other trash before leaving any common area, especially the pool and volleyball court. Use the recycle carts when possible. Sand toys need to be taken home, not left on the volleyball court. The same goes for shoes, clothing items and trash. Please do not take sand from volleyball area to dump under the faucet for playing. The drain does not work well and buckets of sand make it worse. Sand dumped in piles on the grass also will kill the grass. Sand on the deck and deck steps is a slip hazard and also causes the stain to wear off. We just paid to have deck re-stained last year. These are all scenarios the grounds committee has encountered and cleaned up - including grill ashes and coals dumped in landscaped areas! We appreciate neighbors cleaning grills after use, but please be sure to put the ashes and coals in a bag and into the trash cart nearby.

Finally, remember that the trails that border our properties are the homeowner's responsibility to keep cleared of weeds, mulch, dirt, twigs, landscape rocks, branches, toys and overgrowth; even when it is outside our privacy fence and out of sight. The trails are our sidewalks and not the responsibility of any committee member. Trails should be open and safe for passing walkers, strollers wagons etc. Playground equipment should not be on the trail. Trails on a slope are dangerous so these trail hazards need to be swept or raked off. Homes that back to Ridgeview Rd have another responsibility. The fence is aging and weakening from lack of maintenance. We ask that all homeowners on the East side of Hunter keep all growth away from the fence from the inside. No grass, weeds, vines or tree seedlings can be allowed to sneak under, over or through the fence because it weakens the fence and appears unsightly. NWT's paid lawn maintenance crew mows and trims only. They do not regularly clear off vines and weeds from the street side of the fence. That work has been done by grounds volunteers the past few years after it looks bad. Tree limbs also need to be kept pruned up and off the fence. Any limbs that break and fall outside the fence is the responsibility of the homeowner as their property extends beyond the fence.

Our Ridgeview Road fencing and entry beds make a statement to all our visitors, and to all of us that are lucky to live here, that THIS neighborhood takes pride in our appearance. Thank you to all our neighbors and volunteers for helping to make NWT inviting and beautiful.

Also, please do not take food or drinks into the pool. These items must be kept at your table or lounge chair. Please do your part and pick up any trash from your area that you are using. We have had some complaints about excess trash not only in the pool area but also in the immediate area outside of the pool fence. Remember no glass items are allowed on the pool deck at any time.

Please have your pool passes out and ready for the attendants to see. If you do not have your pass with you, you will be turned away to get it. It is important to have your pass because we have had a few cases of non-NWT people trying to use the pool. Because they could not produce a pass, they were not let in. Please remember to be respectful of your neighbors that are using the pool.

New for the pool this year is the large umbrella in place by the baby pool. This was suggested by your neighbors so some of our young swimmers can enjoy the baby pool even when it gets extremely hot out. If you are having a pool party, 3 tables behind the hot tub/baby pool will be reserved for your use during the time of your party. If you are sitting at those table prior to a party, please plan on leaving that table 20-30 minutes before the scheduled party start time. There should be signs attached to the tables with this information if there is a party scheduled. Pool party and emergency contact forms are the responsibility of the home owner to print off and turn in. Please

respect the pool rules they are in place for a reason. Thank you for your cooperation!

ARCHITECTURAL COMMITTEE NEWS

Many homeowners are replacing their shake shingle roofs with composite roofing. If this is something you might be considering please keep in mind the following items. Each homeowner must submit an Architectural request form complete with product information and specifications for approval by the Architectural Review Committee. When shopping for composite roofs there are many color options, however, the NWT Board long ago specified these guidelines for acceptable color for the neighborhood: shall be the color of natural cedar shake shingles or natural weathered cedar shake shingles. Please consider that the only roofs allowed per the original deed restrictions were shake shingles and that the acceptance of composite type roofing is in line with keeping that cedar shake look or as close to that as possible. There are some roofs in the neighborhood that were not approved by the board so while you may see a certain color roof don't automatically assume that it will be approved.
