The picnic area by the pond is also being reseeded and watered by volunteers since there are no in ground sprinklers available. Grass is coming up and we hope to slow the erosion in that area. Many neighbors allow the Grounds Committee access to their water faucets and equipment where we do not have sprinkler systems. #### POND COMMITTEE NEWS

This summer one of the most frequent questions that we have been asked is about the aerators in the pond – when and why they operate and the hours of operation. These questions come from 5 to 80-year-olds so it is good to see that they are noticed. I think the question comes because we all like the look and sound of rushing water, and the grand lights at night.

It is important to recognize that these are aerators not fountains. The difference being the amount of water displayed and the purpose. Our aerators process about 1500 gallons a minute to oxygenate the water. A fountain would only do a few hundred and is for decoration only. Our aerators operate on timers and typically run from 9:30 a.m. – 9:30 p.m. daily from March through October.

Besides creating a pleasant look and sound, the aerators keep the pond healthy and receptive to fish and fowl, and yes – algae and plant growth, and keep the water moving. Hence their operation is important.

We have experienced some problems with the South aerator this summer and its operation has been intermittent. In trying to resolve the problems we have renovated both aerators, changed timers and have gone to school. The school reinforced the idea that our acre of pond does require 2 aerators and ours are perfectly suited to the purpose. The best hours of operation are at night as they run cooler, have less water evaporation and reduce algae growth. Daytime running heats the pond and counteracts the benefits gained at night.

We have had many comments on the operating hours of the aerators. Some want them on longer to hear the rushing water, some want them on less to enjoy the silence. Some enjoy the lights at night and other don't like the

disturbance. We have tried to maintain a balance with these ideas in the past. And will continue to find balance moving forward. In the future we may run a combination of daytime and nighttime aeration. This will allow us to maintain the equipment, keep the pond in its best condition and provide the most enjoyment for all.

# ARCHITECTURAL COMMITTEE NEWS

Neighbors, please be aware that being a member of Northwood Trails means that there are requirements to consider when performing certain repairs or improvements to your property. For instance, architectural changes, tree removal, fencing and roofing are all

property changes that require review by the Architectural Committee as per the deed restrictions.

Recently there have been several homeowners who have not submitted a request for approval and have not received approval for changes to their property which are called for in the restrictions. Avoiding the proper procedures can result in possible legal action by the NWT association.

If you are a homeowner who recently made changes to your property, please be sure to review the Declaration of Restrictions. These Restrictions and the Architectural Request forms can be downloaded from eneighbors.com and submitted to the Architectural Committee chair.
