City Code 6.04.050.D

Placement for Collection. On the day the collection is scheduled for any residential premises, or not earlier than 5 p.m. of the night before collection is scheduled, City provided collection carts and all items to be picked up shall be placed at the street in front of the premises. City provided collection carts shall be removed from the curb as soon after collection of trash as possible, and no later than 5:00 p.m. the day after the collection day. When not at the curb for collection, the carts must be stored inside the garage or beside the residence.

Splish Splash! Pool season is upon us. You must be a member in good standing to have access to the pool, so be sure you have sent your HOA fees to the HOA office. To receive your 2019 pool access sticker, you must complete the emergency contact form and deliver it to the pool attendant upon your first visit to the pool. The form is located on e-neighbors website. Visit eneighbors.com > Documents > Pool Documents. You can also access the pool party form at the same location. The party form reserves three tables for a two-hour window. Pool party reservations are not allowed on national holidays. Note: you cannot reserve the pool tower. Tower access is first come, first serve basis.

Lastly, here are the much awaited pool dates and hours. Based on feedback from the community, we will be opening one hour earlier than we have in the past seasons. The new pool hours this season are 10 a.m. - 10 p.m.

Opening day: Thursday, May 23 (last day of school) from 1 p.m. - 5 p.m.

Regular season: May 24 – September 2 from 10 a.m. - 10 p.m.

Constructive feedback about the pool operations is always welcome and encouraged.
