If you have not yet paid your 2016 dues, please do so now.

#### **GROUNDS COMMITTEE NEWS**

The NWT grounds committee has begun meetings for 2016 and have projects already in the works. Notice that the overgrown plantings have been removed from all the entrances and will be replaced with new plants in the near future. There also has been work done around the pool parking lot to begin the process of replacing some of the weedy beds with grass. Millview Circle is getting some updates with removal of dead shrubs and a combining of smaller beds into larger curved designs which will be getting mulched. Then we hope to plant grass in areas of the circle that need it. Grass will also be planted this spring in the picnic area south of the pond and along Ridgeview Road on the slope south of 114th street.

In the process of walking the areas to outlay the work we wanted DSLawn to complete for us, we found ourselves stepping in dog droppings in the common areas! Lots of it in some areas. Out of respect for our friends, neighbors and the grounds workers "please" do not forget to clean up after your pets whether on common grounds, city/co property along the streamway or in "neighbor's yards". This is becoming a big problem in our beautiful neighborhood.

April 22<sup>nd</sup> is Earth day and we will have a city dumpster in the pool parking lot to be used for (yard waste only), bushes, limbs etc. It will be removed on Monday the 25<sup>th</sup>, and a second dumpster will be delivered again on the 29th for the same usage. Take

advantage of this offer and clean up around your homes and the commons areas. The parking lot will be open those weekends.

The grounds committee's goal this year is to make NWT even more beautiful than it already is. We hope that every resident will take pride in this neighborhood that we are fortunate to live in.

# ARCHITECTURAL COMMITTEE NEWS

The NWT Architectural Committee approved requests for removal of a diseased tree, new vinyl windows and a replacement deck. While it may seem like just an extrastep, please keep submitting requests as the bylaws require. This helps to ensure that our neighborhood continues to look great and ensures compliance with NWT HOA Bylaws and Deed Restrictions.

Path maintenance: one of NWT most coveted amenities is our paths which most likely attracted a good many of us to move here. Our paths are also our sidewalks and as such must be maintained in accordance with city code. While the NWT Board oversees repair and replacement, it is up to each homeowner to remove dirt, leaves and all plants growing from your property onto and over the path. The city of Olathe enforces, with some documented exceptions, the 2012 International Property Maintenance Code. With respect to sidewalks/paths the code is as follows: 302.3 Sidewalks and driveways. All sidewalks, walkways, stairs, driveways, parking spaces and similar areas

shall be kept in a proper state of repair, and maintained free from hazardous conditions.

Reminder of deed restriction on fences: No fence shall be erected without prior written consent. The maximum height of any fence shall be six feet, and the material shall be limited to wood, wrought iron or masonry.
