MAJOR CHANGES IN WASTE DISPOSAL COMING

Residents of Prairie Village are in for major changes in their weekly waste disposal practices starting in May, 2010.

Included in these city wide changes are: A limit on the amount residents can dispose of weekly; the type of containers allowed; and restrictions on yard waste permitted.

Deffenbaugh Industries, Prairie Village's disposal contractor, will distribute new refuse carts in April, one for solid waste and another for recycled items like newspapers, plastics, and cardboard.

Detailed information of the new regulations will be distributed in a special edition of the city's Prairie Village Voice in March.

Each household will receive either a 35-gallon or a 65-gallon trash cart for regular solid waste. Residents will be limited to what fits in the cart, although residents can purchase stickers from the city for overflow. In addition to the regular trash cart, each

household will also receive a 65-gallon recycling cart. Extra recycling carts may be used if a house has more than 65 gallons of recyclable items each week.

Perhaps the most dramatic change is a limit on the amount of bags of yard waste allowed each week. Gone are the days of dozens of plastic bags full of leaves each fall. Each house will be limited to a set amount of bags, which varies depending on the time of year, for each month. Leaves must also be in biodegradable paper bags. Plastic yard waste bags will no longer be allowed.

The scheduled changes stem from the Johnson County Solid Waste Management Plan and a contract with Deffenbaugh and will be implemented city-wide starting May 3, 2010. Questions and comments regarding the changes should be addressed to City Hall in Prairie Village.
