#### **WESTMONT BOARD MEETING NEWS**

#### **VICE PRESIDENT'S REPORT**

**Property Values:** Vice President Shirley Knese reported several homeowners have recently contacted her about exterior home repairs and improvements based on their Property Values reports. In January, at their request, Shirley plans to meet individually with each to review the report. Shirley did this last fall too, and many homeowners and landlords followed through with needed repairs and improvements.

## TREASURER'S REPORT

**Financials:** The November financial statements and expenses were reviewed and discussed at the December Board meeting. All agreed financials to be in order.

**Certificates of Deposit:** To earn interest income on a portion of Westmont Association's Reserve Account, a 6-month and 12-month CD have been purchased. The Board members, with guidance from HA-KC, reviewed several options before making this investment.
