<u>Property Inspections:</u> Half of the property inspections have been completed and will hopefully be mailed out soon. It has always been a goal of our Association to maintain the over-all appearance of our homes in order to sustain and increase the value and overall appearance of our neighborhood.

<u>Properties Bordering Antioch Street and 119th Street:</u> If your property boarders the perimeter fence, here are the things you are responsible for: 1) trim all branches that hang over the fence <u>(For your life and safety, do **NOT** cut branches growing into electrical wires attached to poles, contact the City of Overland Park. They will trim them.); 2) maintain the entire back yard as you do the front of your property: pick up fallen stick/branches, repair eroded bare soil, remove weeds, dead vegetation, trash, and so forth.</u>

If you have branches from a neighbor's tree growing over your property line, fence or house, you can legally have them cut back at your own expense. It's suggested you and your neighbor try to work together on this.

VICE PRESIDENT'S REPORT

Vice President Shirley Knese presented nine ARC forms for approval. That's a monthly record! On our streets, we've seen all kinds of vehicles belonging to skilled painters and remodeling specialists. Cheers to the do-it-yourself folks, too. With each homeowner's improvements, all of Westmont benefits!

Important: Before Starting Exterior Home Improvement: Don't schedule your contractor and begin the project until your ARC form has been signed and returned to you. An ARC application is a MUST.

<u>TREASURER'S REPORT:</u> Treasurer Bev Kitts reviewed the June financial statements and expenses with the board and a discussion followed. All agreed financials to be in order. Information about dues is on HAKC website: www.ha-kc.org -search for Westmont and Maintenance Fees.

LAWN AND GROUNDS REPORT: TLC will spay a high nitrogen application on our grass August-September. And John Rudzinski individually is meeting with many home owners who are dealing with complex drainage issues

<u>Look on each side of your Pin Oak tree</u>. If the leaves are light green-yellow and dropping, it is dying. Many are in Westmont. Without an iron treatment injection done by a professional, it will be dead in a few short years. TLC will give you a bid with a 20% discount. The cost of cutting down a dead tree is much greater.

<u>Problematic New Family Moves Into Westmont:</u> A family of 8 raccoons or more are in the neighborhood. They can live in underbrush, under your deck or porch, climb fences, be destructive to your house, aggressive, and dangerous to your pets. Call OP Animal control if you see them. Oh...and the raccoon kids are scouting for their own new homes.

August Garbage Collection: It will be picked up at 6am because of extreme heat and humidity.

<u>Where are your recycle and trash bins?</u> On the driveway, Tuesday-Wednesday. Otherwise, they should be parked in a place where they can't be seen from the street.
