Just complete and return an authorization form with your account information to Homes Association of Kansas City. It's that easy.

And so it begins. Precision Lawn plans to start mowing on Thursday, April 6th. Prior to this date I will survey the grounds to make sure we are ready for this first mow of the season. That said, please remember to unlock your gates if you want your backyard mowed. Also keep in mind that Westmont pays for basic lawn care as opposed to custom. If you do not want your yard mowed, please indicate with a sign.

The week following, they will be mulching the common areas. They will be applying the second round of fertilizer and crabgrass control to our yards. This application will kill new grass seed. If you do not want it, please put a sign in your yard.

This is a good time, if you have not already done so, to remove the straw mats/plastic netting the gas company put down last Fall so new grass can grow and the lawn mowers do not run over them.
