## TREASURER'S REPORT – Blaine Halvorson

**Overview** – for the first nine months of 2025, the Board has been extremely efficient in operating within our projected budget. As a result, if we continue to manage our spending, there is no need for a dues increase for 2026.

Goals -- One of the most important goals is getting everyone to pay their monthly dues on time. It's one way to keep our dues extremely low. If you mail in your payments, please allow for extremely slow mail service. Payments must be received by the HA-KC no later than the 20th of each month. Payments received after the 20th are assessed a small late fee, which must be paid with the following month's dues. One alternative is to sign up for automatic withdrawal -- a quick and convenient way to pay the monthly dues. ### LAWN AND GROUNDS REPORT - John Rudzinski

**Shrub Trimming** – The trimming will be done in the coming weeks. If you don't want your shrubs trimmed, please put out a sign. Directory Spot and the mailbox flyers will give the specific dates.

**Leaf Cleanup** – Precision will perform the first leaf cleanup mid-November and the second mid-December. Homeowners should clean-up whatever they can at other times.

Winter Fertilizer - Precision will apply a winter fertilizer in November AFTER the first leaf clean-up.

**Sprinkler Shutdown** – PRECISION IS NO LONGER DOING THIS SERVICE. The Board does not endorse any other company, but we can offer suggestions for you to contact and arrange for sprinkler shutdown on your own.

**Waste Management** -- Our collection day is Friday. Do not overload the bins; the lids should close completely. Garbage left beside the carts may NOT be collected. Please do not park on the street so that it might inhibit the trash truck's ability to pick up the bins. After pick-up, put your bins out of sight in your garage.

Fall Is Here! – Fall is the perfect time to trim trees and remove any dead branches before winter weather arrives.

**Acorns** -- We're also being "blessed" with plenty of acorns this season! It is important to keep them off your sidewalk and driveway. The Walkers, especially, will appreciate your thoughtfulness when they do not trip and fall. Put your YARD waste in PAPER yard waste bags. Do not sweep the acorns into the street -- they will clog the storm drains. Waste Management will collect up to TEN (10) bags per household each week on trash days.
